Committeeman McNinch suggested that everyone should read section 69 of the Ordinance which if followed a lot of the issues will be taken care of. Mr. Lembeck explained to the committee how he can make the Columbia Beach nicer which will bring more people in. Mr. Lembeck has a call in to see if he can use the Clean Communities for adopt a beach to see if he can get

Mr. Lembeck also explained that Clean Community Day can still happen as long as it's in groups of 10 and they must wear masks and gloves.

Mayor Starrs asked the committee for approval to take funds from the Community Day to help pay for beach costs. Committee agreed to use the 2020 funds set aside for Community Day, which is now cancelled, to purchase riprap to improve the gullies and ruts at Columbia Beach.

#### **ORDINANCE**

### Introduction

# 2020-06 – An Ordinance of the Township of Knowlton Amending Chapter Section to Require that certain parking location to be subject to regulation 3(G)(9)

WHEREAS, the Mayor and Committee of the Township of Knowlton have determined that it is necessary to require that certain parking locations be subject to regulation; and

WHEREAS, the Mayor and Committee of the Township of Knowlton have further determined that it is necessary to regulate such parking by requiring permits to be obtained and to establish reasonable restrictions regarding same; and

WHEREAS, the Township of Knowlton Ordinance § 174-14.1 provides a schedule identifying such areas where parking permits are required; and

WHEREAS, the Mayor and Committee of the Township of Knowlton wish to revise and update said schedule so as to add Columbia Street and a portion of Washington Street to said schedule.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Knowlton, Warren County, New Jersey, as follows:

Section 1. The Code of the Township of Knowlton is hereby amended by revising Chapter 174, Section 14.1 to read as follows:

§ 174-14.1 Schedule IA: Permit Parking.

In accordance with the provisions of § <u>174-3G</u>, no person shall park a vehicle at any time upon any of the following described streets or parts thereof, unless the vehicle shall bear a valid permit:

Section 2. The Code of the Township of Knowlton is hereby amended by revising Chapter 174, Section 3(G)(9) as follows:

§ 174-3(G) Parking only on Certain Streets

(9) Any vehicle parked in violation of the parking permit regulations will be subject to a fine of \$100.00 or removal pursuant to this section. Persons in possession of parking permits who misuse them, including obtaining them for purposes other than hunting, fishing, biking, and hiking, are subject to revocation of the permits for one year and a fine of \$150.00. Any person(s) found to possess an invalid, expired, or counterfeit permit shall be subject to a fine of \$150.00

Section 3. All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.

Section 4. This ordinance shall be construed consistent with the purpose stated in section 1 hereof. If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance amends provisions of the Knowlton Township Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Township of Knowlton Code.

Section 5. This ordinance shall take effect immediately upon approval and publication of notice of adoption as provided by law

2020-99-Resolution Urging Governor Murphy to Reimburse County Governments with Populations of 500,000 Residents or Less with Federal Monies from the Coronavirus Relief Fund (CRF) Under the Coronavirus Aid, Relief, and Economic Security (Cares) Act for the Extraordinary Expenses Incurred in Combating the COVID-19 Public Health Crisis.

WHEREAS, county governments have led the way on the front lines and played a vital role in providing essential services and protecting the public health, safety, and welfare of residents across the Garden State during this once in a generation pandemic; and,

WHEREAS, county governments have incurred substantial costs in responding to the COVID-19 public health crisis by operating test centers, purchasing and distributing personal protective equipment, hiring public nurses, implementing mitigation measures, disinfecting county facilities, sheltering homeless and at-risk individuals, managing correctional facilities, administering social services programs, conducting elections, and more; and,

WHEREAS, under the CARES Act, the State of New Jersey received \$2.5 billion in federal CRF monies to alleviate the staggering financial burden imposed by the COVID-19 public health crisis and of which the United States Department of Treasury authorized to provide much-needed relief for local governing bodies that did not receive direct aid because their populations fell below 500,000 residents; and,

WHEREAS, the Treasure of the State of New Jersey allocated \$250.0 million in CRF monies to the Local Government Relief Fund in the Department of Community Affairs (DCA) to reimburse local governing bodies for COVID-19 related expenses but has yet to release any funding while county governments continue to spend millions in limited property taxpayer dollars battling the COVID-19 public health crisis.

NOW, THEREFORE, BE IT RESOLVED that the Township of Knowlton County of Warren urge Governor Phil Murphy to reimburse counties with populations of 500,000 residents or less with federal monies from the Coronavirus Relief Fund (CRF) under the Coronavirus Aid, Relief, and Economic Security (CARES) Act for the extraordinary expenses incurred in combating the COVID-19 public health crisis.

BE IT FURTHER RESOLVED that certified copies of this Resolution are forwarded to the Governor of the State of New Jersey Phil Murphy; the President of the New Jersey State Senate Steve Sweeney; the Speaker of the General Assembly Craig Coughlin; the congressional and the legislative delegations Warren County; the clerks of the board of chosen freeholders in Atlantic, Burlington, Cape May, Cumberland, Gloucester, Hunterdon, Mercer, Morris, Salem, Somerset, Sussex and Warren counties; the municipal clerks in each of the municipalities located with Warren County; the New Jersey State League of Municipalities; and , the New Jersey Association of Counties.

# 2020-100- Award Contract for the Acquisition of Air Packs for Knowlton Township Fire & Rescue

WHEREAS, the Township of Knowlton wishes to purchase Air-packs to replace ones that no longer meet state requirements; and

WHEREAS, the Township wishes to award a contract to Firefighter One, a registered entity in a co-op to which Knowlton belongs; and

WHEREAS, the Chief Financial Officer has certified that funds are available thru Capital Ordinance 2020-05 within the General Capital Fund.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Knowlton, County of Warren, and State of New Jersey enter into a contract with Firefighter One 34 Wilson Drive Sparta, New Jersey for the purchase of 14 Air-packs, net trade in, not to exceed \$99,935.00.

# 2020-103- Resolution Requesting the Planning Board Draft a Certain Zoning Ordinance Amendment

WHEREAS, Columbia Beach, designated on the Tax Maps of the Township of Knowlton as Block 19, Lot 4, is a public beach owned by the Township of Knowlton (the "Township"); and

WHEREAS, pursuant to Section 69-3(a) of the Code of the Township of Knowlton (the "Township Code") residents of the Township may obtain permits to access Columbia Beach for the purposes of boat launching, fishing, boating or picnicking; and

WHEREAS, Section 69-3(b) of the Code of the Township of Knowlton (the "Code") provides for a process to allow owners of licensed campgrounds within the Township to obtain permits for campground patrons to access Columbia Beach for the purposes of boat launching; and

WHEREAS, the Township Code (specifically Article 38) does not permit commercial activities in the VR-Zone; and

WHEREAS, Section 69-3(b) of the Code, which allows use of Columbia Beach for commercial purposes (i.e. boat launching for local campground patrons), appears inconsistent with the Article 38 of the Code governing the VR-

Zone; and

WHEREAS, the Township Committee, therefore, requests that the Township Planning Board examine this inconsistency and draft revisions to the Township Code permitting the type of activity contemplated by Section 69-3(b) of the Code (i.e. boat launching by patrons of local campgrounds).

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Township Committee of the Township of Knowlton, County of Warren, New Jersey, that the Township Planning Board is requested to review the above-referenced zoning ordinances and propose amendments to the Township Code to permit the activity contemplated by Section 69-3(b) of the Code (i.e. boat launching by patrons of local campgrounds).

BE IT FURTHER RESOLVED, the Township Committee requests that the Planning Board incorporate reasonable conditions into such proposed ordinance, such as a limitation of the number of permits issued, provision of insurance, and / or hours of operation.
