The monthly meeting of the Knowlton Township Committee was held on this date at the Municipal Building, 628 Route 94, Columbia, New Jersey. This meeting was called to order at 7:05 p.m. by Mayor Starrs. Mayor Starrs led the public in the pledge of allegiance.

### DEPARTMENT REPORTS

#### Engineer Ted Rodman

Salt shed is ready to go out for bid. Question regarding when bids should be accepted took place with

the committee and attorney.

Stormwater management is a program that NJDEP is asking all townships participate in. Mr. Rodman said that Knowlton Township has 9 points out of 12 that are needed to fulfill NJDEP requirements

State aid is due October 6th for Station/Kill Rd.

Mr. Rodman received a phone call from NJDOT regarding engine breaking on Route 46. Mr. Rodman asked where the engine breaking is happening. Committee said that the complaint was from Hunter's Lodge so it must be near there.

Mark Houston from NJDOT will be putting signs on Route 94 for no truck turn around near Brook Hollow Winery.

No update regarding Washington Street.

### **DPW Supervisor Brian Peck**

No updates from Mr. Peck.

Deputy Mayor Cuntala inquired about the no truck turnaround sign on Mt. Pleasant. Mr. Peck said a larger sign has been ordered.

Committeewoman Shipps took a tour in the DPW building and explained to the committee that there is a truck that can only be used for plowing not salting. Mayor Starrs had mentioned that the new auditor asked for the committee to come up with a Capital Wish list to prioritize what the township's needs will be. Deputy Mayor Cuntala will get that list together. Committeewoman Shipps also said that the auditor also mentioned on having a list of when equipment should be repaired and or replaced.

Mayor Starrs asked Mr. Peck when the 2<sup>nd</sup> roadside trimming would be happening. He said not until October. Mayor Starrs asked if they gave part-time DPW worker Geoff Littlehale extra hours would that help in order to get the trimming done he said it would.

Motion was made by Committeewoman Shipps, seconded by Mayor Starrs and approved by roll call vote Cuntala--yes, Farber--yes, Shipps--yes, Van Horn--absent, Starrs-- yes to have part-time DPW worker work additional 30 hours spread out through the next few weeks so roadside trimming can be done earlier. Hours to be arranged so that overtime is not incurred.

### **Fire Official Glenn Wilson**

### **Division of Fire Safety**

Mayor Starrs had asked Mr. Wilson to come to tonight's meeting because she recently discovered that the Division of Fire Safety offers a free service and would like to discuss the pros and cons of having our own Fire Official.

Mayor Starrs stated that we get a LEA rebate which fluctuates every year depending on the number of applications that come in, but the township does get approximately \$3,000 to \$3,500, which pays for part of Mr. Wilson's salary.

Mr. Wilson explained to the committee the currently that the township is not losing money. Last year the township received \$6,062.74 in fees. Mr. Wilson's annual wages are \$6,060.00. Mr. Wilson makes himself available to residents to do the inspections on weekends so that residents do not have to take off from work for a 20-minute inspection. Knowlton Township has a lot of time sensitive

issues such as the camps, nursing home, and schools, some of which need to be inspected quarterly. Committee agreed that we should not switch to the state Division of Fire Safety.

WHEREAS, the Federal Government has been paying these monies to the County of Warren; and WHEREAS, Federal park land in Warren County totals 9,222 acres, and

WHEREAS, of that 9,222 acres, 979 acres, or 11% is located in Knowlton Township, and

WHEREAS, 7,804 acres ,or 85%, is located in Hardwick Township, and

WHEREAS, 439 acres, or 4%, is located in Blairstown, and

WHEREAS, the Township has agreed that the Federal Payment in Lieu of Taxes, which is normally in the range of \$21,000 to \$22,000 annually, shall be distributed among the affected Municipalities by the County of Warren based upon the above-captioned percentages.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of Knowlton, that the Township agrees that the percentages set forth above are equitable, and agrees to accept 11% of the annual PILT money provided to the County of Warren by the Federal Government.

### Community Day-change of date to September 30th

### **Prosecutor Professional Service Contract**

Mayor Starrs made a correction regarding the Prosecutor's Contract. At the July 10th Township Committee meeting she said that the prosecutor would be receiving \$700 per session he is actually making \$750.00 per session.

#### BPU/CenturyLink meeting on August 2, 2017

Mayor Starrs explained that she along with the Mayors of Hope Township and Hardwick Township

were present at this meeting. The Mayor can not give out specifics of the meeting until next month but there are going to be good improvements in Internet service for Knowlton residents.

### NJDEP Salt meeting on August 7, 2017

Mayor Starrs met with NJDEP. The next engineering phase is moving ahead and it is at no cost to Knowlton Township. At the end of this process there should be a long term solution set forward for the residents affected by the salt. Knowlton Township is not obligated to accept the proposed solution. Mayor Starrs said her goal will be to find a grant to pay for the longterm solution once the study is complete.

## Security System

Mayor Starrs was able to find a security system that is being used in Washington Township and Phillipsburg; It is internet accessible and has a 4-month capacity. The cost for installation is \$699 plus a \$480 annual maintenance fee. If the township went with this system they would save \$800.00 this year and approximately \$1,500 every year after this. The committee discussed some other questions that they had regarding the new system. Mayor Starrs will address those questions with the company and get back to the committee at the next meeting.

### NEW BUSINESS

Division of Fire Safety—Discussed during Department Head Reports

# **DPW Generator**

Notification from the State of New Jersey was sent four years after the generators were installed that a final inspection was never done. DPW called the State and the inspection failed because of an installation problem. A final permit was never issued. Mayor Starrs prepared a draft letter to send to the contractor who installed the generators.

Motion was made by Mayor Starrs, seconded by Deputy Mayor Cuntala and approved with an all-infavor vote to send out the letter in the Committeemember's packets to the contractor asking him to rectify the problems and provide proof of final successful inspection for all 3 generators.

# Fee Ordinance for Tunnel Field

There is an ordinance from 2006 for Tunnel Field and the township has not been charging the correct fees for rental of the Pavilion. What is online is not accurate. Mayor Starrs will make the correction on the website and the Mayor will also send out a memo to CFO Christine Rolef and Recreation Dennis Lembeck regarding the changes.

# Blue light permits

Motion was made by Committeeman Farber, seconded by Mayor Starrs and approved by an all-infavor vote to fill out and sign Blue Light Permits for three of Knowlton Township's Fire & Rescue Volunteers.

# **Lights for Ambulance**

The LED lights are not working on the current ambulance and F&R would like the township to help upgrade their lights. EMS Captain Dave Neal had not received a quote but is getting one from Strykers.

Fire & Rescue is also asking for the township to purchase a new stretcher that would accommodate

larger patients. The cost of a new stretcher is \$23,629.80. Mayor Starrs asked if St. Luke would be willing to donate a stretcher. Committeewoman Shipps will look into it.

#### Simpson Road

Update from last meeting where a resident wanted to enforce no parking on Simpson Rd. Mayor Starrs reached out to Warren County and there was a resolution passed in 1992 for no parking along Simpson Rd. Knowlton Township DPW has ordered the signs and they will be put up when they are received.

#### **Registry of Abandoned Buildings**

Mayor Starrs recently discovered that Blairstown Twp. received almost \$17,000 in bank fees from banks who were not notifying the township of the representative to take care of the property. Knowlton's Committee agreed to amended the vacant property ordinance so that we have a registry and can collect similar fees.

#### Route 46 Route 80 to Walnut Rd., Pavement

Notification from NJDOT that they will be repaying the interchange of 46 to Walnut Rd. NJDOT will be setting up an information meeting at Knowlton Elementary School. No date has been set yet.

Motion was made by Deputy Mayor Cuntala, seconded by Committeewoman Shipps and approved by an all-in-favor for the June 28, 2017 Executive Session Meeting minutes. Committeeman Farber abstained.

Motion was made by Mayor Starrs, seconded by Deputy Mayor Cuntala, and carried to adjourn tonight's Township meeting at 9:15p.m.

Motion was made by Mayor Starrs, seconded by Deputy Mayor Cuntala and approved by an all-infavor vote to return to regular Session at 9:16p.m.

## Regular Session was reopened due to residents asking to make public comments.

Resident Myles Bartos had a question regarding how a house obtained a certificate of occupancy (CO) that does not have railings on the front porch or a deck where there is a sliding glass door. Mayor Starrs said that the Construction Code officials, who work for the State of NJ, issue those certificates. Attorney St. Angelo said that a complaint would need to filed with the State Construction Code official.

Mr. Bartos also asked the Mayor to repeat her comment on hiring a temporary Zoning officer. Mayor Starrs explained that there was a motion made to hire an alternate Zoning officer to handle any issues where the current zoning officer has a potential conflict of interest. The township attorneys decide what is a potential conflict of interest.

Mr. Bartos explained that after a Board of Adjustment meeting, Zoning Officer Joe Rossi said to another resident, "Let's agree on how we are going to handle this." Mr. Bartos feels that there is collusion going on.

Mayor Starrs explained that when litigation is involved they are not able to comment, and must leave it to the attorney to handle.

Mr. Bartos understood that and wanted to bring it to the Committee's attention.

Resident Frank DeGroot asked what are the residents of Auble Road are supposed to do in the meantime. Mr. DeGroot referenced a letter that was sent out by Mr. Rossi and that they took it as a threat.

Resident Jeanne DeGroot said that it is sad that they need to try to get someone that will give them fair, equal treatment Mrs. DeGroot also mentioned a letter that Township Attorney Dick Cushing prepared as a draft for Mr. Rossi to review and approve. Mr. Rossi forwarded the letter to Mr. Tombalkian without notifying Mr. Cushing. Mrs. DeGroot said that is collusion and the steps that Mr. Rossi keeps taking are going to put them in litigation with the township.

Mrs. DeGroot asked if there was any resolution with the fence. Mayor Starrs said that they were advised by Township Attorney that they are not an appeal board and that the committee can not weigh in on that situation and if they wished to appeal the decision of the zoning officer, it would need to go in front of the Board of Adjustment.

Mayor Starrs said that the committee took steps tonight because they can see the difficulty and that they are not going to comment publically and put the township at risk of litigation. Mr. DeGroot said, "You are already at risk."

Mrs. DeGroot mentioned that while waiting in the hallway during Executive Session Mr. Rossi was speaking with Fire Official Glenn Wilson regarding his situation with Auble Rd. and Mr. Rossi said to Mr. Wilson, "They are going to be sorry for taking action." Mr. & Mrs. DeGroot said they felt threatened by his comments and the zoning officer's letter that he sent out.

Attorney St. Angelo explained that if a resident feels threatened they should call the state police. The township committee is not a place to complain about crimes and that because of State laws the committee is not allowed to discuss personnel in public session.

Mr. Bartos asked if anyone has driven by to see if the fence is within the Township ordinance. Mayor Starrs explained that the committee can not comment on the fence matter.

Committeeman Farber suggested having a resolution by the next meeting for an alternate zoning officer.
