2019-123-Award Contract Paving of Hemlock Road

WHEREAS, the Township of Knowlton is a member of the Morris County Cooperative Pricing System and wishes to utilize various contracts for the paving of Hemlock Road; and

WHEREAS, Tilcon New York, Inc. New Jersey has been awarded Contract #6 for Road Resurfacing and Contract #5 for Paving Materials. This has been awarded through the Morris County Cooperative Pricing Council of which the Township of Knowlton is an active participant; and

WHEREAS, Denville Line Painting, Inc. New Jersey has been awarded Contract #36 for Traffic Striping on Roadways. This has been awarded through the Morris County Cooperative Pricing Council of which the Township of Knowlton is an active participant; and

WHEREAS, the Chief Financial Officer has certified that funds are available thru Capital Ordinance 2019-01 within the General Capital Fund

OLD BUSINESS

Citizens of Distinction-resolution draft—Tabled

In REM Foreclosures/Notification to Neighbors

Mayor Starrs explained that the lots now have final judgement with the exception of one that was redeemed. Mayor Starrs prepared a draft letter to send to adjoining property owners for the committee to review. Committeeman McNinch requested to speak with other committees such as environmental, open space and historic regarding these properties and get their input. Committee agreed and will revisit this at the October 24th meeting.

Rockwall update

Committeeman McNinch commented that there was a nice letter from the Warren County Freeholder objecting to the funding of the Route 80 Rockwall and on July 26th the Historic Commission sent a

letter to the Governor and the NJDOT.

Mayor Starrs stated that there have been 213 letters received in this office opposed to the Rockwall. Mayor Starrs also found out that the funding for all NJDOT is approved by a board called NJTPA North Jersey Transportation Planning Authority. There is a Warren County Freeholder who is on that board and he requested that the project be rejected. Mayor Starrs wrote a letter to the board as well as forwarding all 213 letters opposing the rock wall, requesting that the project be rejected. They are going to vote on this September 9th in Newark, which is a public meeting. Mayor Starrs and Mayor Duffy from Hardwick will go to the meeting.

Motion was made by Mayor Starrs, second by Committeeman McNinch and approved by a roll call vote: Cuntala---yes, McNinch--yes, Shipps--yes, Van Horn--absent, Starrs--yes to request letter of support from our Legislators to have the Route 80 Rockwall Project removed from the current TIP.

Resident Tara Mezzanotte explained that she called Senator Booker's office pressuring them for a position. Senator Booker's office called Mrs. Mezzanotte that day stating that the request is in for a briefing with the NJDOT and they will be bringing every question that the township has and coming back with answers.

Hemlock Rd. Update

Mayor Starrs explained that at the last meeting there was motion made to have the township engineer and OEM representative take a look at Hemlock Rd. and make the call if the road should be closed. DPW Supervisor went with them on the site visit and it was not suggest to close the road but to shore it up. The expense was more then expected and there is going to be another load of stones. The cost will be taking out of DPW budget.

NEW BUSINESS

Hope Township Ordinance

Committee was provided with a copy of Hope Township Ordinance regarding warehouses that are proposed to go in along 519 in White Township. Mayor Starrs felt that the committee may want to discuss the ordinance because there will be an increase in truck traffic on Route 46 and Route 519 which is why Hope Township has passed an Ordinance to oppose of the warehouses.

Tom Bodolsky, Vice President, and Theresa Chapman, President of the Citizens of Sustainable Development Organization were present at the meeting and explained to the committee why they are against this warehouse. An application has not been submitted yet. One of the main reasons is because the site is prime farmland and the increase of truck traffic on route 519 and route 46. Mr. Bodolsy provided the committee with a traffic chart showing the possible increase in truck traffic. After discussion the committee agreed to pass a resolution at the next township meeting opposing the warehouses along Route 519 in White township.

Seat on Air Liquide Community Advisory Panel (C.A.P.)

Mayor Starrs requested to have committee members rotate going to the Air Liquide meetings which is held on 1st Wednesday of every month. Mayor Starrs was attending the meetings but is no longer able to. Committee agreed to rotate.

Parking on Township property

There is an issue with residents parking on township property and the Zoning officer would like direction on how the committee would like to handle it. Committee agreed to be consistent and not allow parking on any Township property and to have the Zoning Officer begin by politely requesting not to park there.

CORRESPONDENCE

Rich Rd.—Resident is requesting to make repairs to the road. Committeewoman Cuntala will follow up with DPW Supervisor Brian Peck.
