# MINUTES OF KNOWLTON TOWNSHIP WARREN COUNTY, NEW JERSEY Public Session Meeting Minutes February 27, 2020

The meeting of the Knowlton Township Committee was held on this date at the Knowlton Municipal Building, 628 Route 94, Columbia, New Jersey. This meeting was called to order at 7:01 p.m. by Mayor Starrs.

### **PRESENTATION**

# **Nature Conservancy Beth Styler Barry- Columbia Dam Update**

Beth Styler Barry presented a slide show regarding Columbia Dam. The slide show had a mockup of the Historic Signage, trees that were planted, and where the trail will be. Ms. Barry explained that the NJDEP owned the powerhouse and has demolished it. The area is still closed and will not be open to the public until January 2021 the earliest.

# **PUBLIC COMMENT**

Resident Rene Mathez asked if there were any plans with the Coronavirus going around. Mayor Starrs explained that she spoke with the Warren County Health Dept. and they are on top of it. Their primary concern is the schools. They will be meeting with all the Emergency Management Teams to give them guidance. The Health Department also suggested the municipalities have a plan. Committee agreed to have Frank Makowski to put a plan in writing.

Resident Fred Kessler has concerns about the Knowlton Athletic Association. He is asking to see the current terms on KAA to have a term limitation. He feels that since Knowlton's tax dollars are going toward paying KAA insurance, that the committee should have a say. Mayor Starrs explained to Mr. Kessler that this is an attorney question and that she will ask the Township Attorney at the next meeting.

Resident Tracy Albertson questioned why School schedule was on the Agenda. Committeeman Van Horn explained that he asked for it to be put on the Agenda because a change in school calendar could affect local farmers and their farm help. Ms. Albertson said that the calendar has not been approved yet and that it was a matter to be discussed at the school board meeting.

Majority of the Committee agreed that is not a discussion that the committee should be having and it should be addressed with the school board.

# **Township Engineer Ted Rodman**

Mr. Rodman discussed with the Committee regarding the erosion under Route 80. Mayor Starrs read an email that she received from NJDOT which said that the erosion is not an immediate safety issue but does need repair. NJDOT will be evaluating the erosion. Mr. Rodman will go look and invite DPW Supervisor Brian Peck. State Aid Paperwork is done just needs Mayor's signature. Mr. Rodman also needs Mayor Starrs signature on paperwork to be sent to NJDEP for the Four-log system.

- 1. The Statewide DVP (which is attached hereto) shall be included in the Manual.
- 2. Kristin Shipps, Clerk for the Township of Knowlton shall be designated as Primary Human Resources Officer (HRO).
- 3. Adele Starrs, Mayor of the Township of Knowlton shall be designated as Secondary HRO.
- 4. The Table of Contents shall be updated to reflect the inclusion of the DVP.

BE IT FURTHER RESOLVED that a copy of the updated Township of Independence Personnel Policies and Procedures Manual is on file with the Clerk's office; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Township Clerk for distribution to all Township employees.

The committee agrees to pay \$1,500.00. KF&R needs to come up with the remainder of the cost which totaled \$4,500.00.
