NJDOT Route 80 Rockwall Open House Review

Committee members addressed how they thought the June 18, 2019 Open House pertaining to the DOT's plans to install a rockwall on Route 80 through the Delaware Water Gap went. Committeeman McNinch felt that residents received a lot of information. Committeewoman Cuntala felt that it was a great turn out. Mayor Starrs suggested having the legislators request financials or a study on the economic impacts that four or more years of construction will have on area businesses.

Rockfall Mitigation Draft Letter

Motion made by Mayor Starrs, second by Committeewoman Cuntala and carried to approve two draft letters to the NJDOT regarding their Rockfall Mitigation Project: one regarding how the NJDOT will measure and protect the air quality in Knowlton during 4 to 5 years of traffic congestion on Route 80 and one clarifying questions from the Open House.

Mayor Starrs discussed that all comments received on the project would be forwarded to the Governor, the DOT Commissioner, and the DOT project team. The Committee agreed that statements made during the Open House would be sent to NJDOT in transcript form by our municipal office.

Township Engineer Ted Rodman

Discussion regarding no parking signs along Simpson Rd. The signs need to be 200 feet apart and also need to be breakaway signs. The signs are to run from McDonalds down to Starlite Rd.

Stark Rd. and Station/ Kill Road are scheduled to be paved around July 29th. The date is weather dependent and may change.

Tunnel Field —application has been sent to NJDEP to issue the permit to fix the water issue at Tunnel Filed.

Mr. Rodman needs to nominate a road for paving for the State Aid grant application. He will discuss with DPW Supervisor Brian Peck.
