Deputy Mayor Cuntala agreed to also speak with DPW Supervisor Brian Peck.

# 2018-94- Award of Contract for Road Resurfacing (Kill/Station Road)

WHEREAS, The Township of Knowlton is a member of the Morris County Cooperative Pricing System and wishes to utilize the contract for Road Resurfacing for Resurfacing of Kill / Station Road; and

WHEREAS, Tilcon New York, Inc., Wharton, NJ has been awarded Contract #6 for Road Resurfacing through the Morris County Cooperative Pricing Council of which the township of Knowlton is an active participant; and

WHEREAS, Denville Line Striping, Rockaway, NJ has been awarded Contract #36 for Traffic Striping through the Morris County Cooperative Pricing Council of which the township of Knowlton is an active participant; and

WHEREAS, the Chief Financial Officer has certified that funds are available.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Knowlton, County of Warren, and State of New Jersey that road resurfacing services for Kill / Station Road, is awarded to Tilcon New York, Inc., 625 Mt. Hope Road, Wharton, New Jersey 07885, in the amount not to exceed \$164,025.40; and Denville Line Striping, Rockaway, NJ, in the amount not to exceed \$9,990.00. ## Township Engineer Ted Rodman

Still have not heard back from NJDOT regarding the problem statement on Route 80 entrance from Simpson Rd.

Polkville Rd. there will be a preconstruction meeting for paving. No date has been set yet.

Speed limit signs for Koeck Rd. were approved by NJDOT. The original approval put up 10 signs, 5 facing south bound, 5 facing north bound. Most of these signs are probably gone. DPW Supervisor Brian Peck will replace the missing signs.

Township Engineer Ted Rodman said a driveway permit has been issued to the Nature Conservancy to use Bruglar Road for the Columbia Dam project.

Nelson Tree Service asked if they could take that tree down because of ash borer, which is a bug that has infested New Jersey and causes ash trees to die. The tree service will take the tree down and cut it up but it's the township's responsibility to get rid of it. Committee agreed that the tree should be taking down.
