### **Reorganization**:

#### **Election of Chairman**

Attorney Leo called for a nomination for the election of a Chairman. Mr. Glynn made the motion to elect David Smith as Chairman. With there being no second, the motion died.

## **Approval of Minutes:**

Ms. Murray made the motion to adopt the minutes of November 24, 2015. Motion seconded by Mr. VanHorn. Roll call vote: Smith-Yes, VanHorn-Yes, Murray-Yes, and Taylor-Yes. Not eligible to vote on the minutes as they were not present at the November meeting: Glynn, Costantino, Bromm, Cuntala, and Starrs.

#### Other:

The correspondence was reviewed. Mr. Bromm asked if a site plan was ever approved for the "BP" gas station, as referenced in the Zoning Officer's memo. Board Secretary Schemm stated that she is not sure of what is in the file. The Board then acknowledged the letter from Kenneth Weintick in regards to Delaware River Family Campground.

Ms. Murray questioned the status of the Wastewater Management Plan. Mayor Starrs addressed the matter and she stated that there will be a presentation at the March Township Committee Meeting. The sewer plant/sewer service area/build out/capacity was discussed with the Board.

The Board then reviewed the LOI request from Marksboro Holding Company.

Mr. Bromm updated the Board on the Warren County Preservation Day to be held in May at the Ramsaysburg Homestead.

Ms. Murray updated the Board on the submitted scenic by way application and the possibility of it being extended, which was discussed with the Board, at great length.

Mr. Smith asked if the Board has received any feedback from the Township Committee on the sign ordinance. Chairman Taylor stated that the Planning Board can always revisit the matter if the Township Committee has specific concerns.

#### **Open to the Public:**

Chairman Taylor opened the meeting to the public. With there being no public comment, the meeting was closed to the public.

Mr. Van Horn questioned the status of the Affordable Housing issue. Mayor Starrs stated that the Township would look to possibly settle if the Township were to get fair numbers. Attorney Leo also provided some additional input on the process.
