# PUBLIC MEETING MINUTES OF THE KNOWLTON TOWNSHIP COMMITTEE WARREN COUNTY, NEW JERSEY November 13, 2017

The monthly meeting of the Knowlton Township Committee was held on this date at the Municipal Building, 628 Route 94, Columbia, New Jersey. This meeting was called to order at 7:01 p.m. by Mayor Starrs. Mayor Starrs led the public in the pledge of allegiance.

#### **PUBLIC COMMENT**

Motion was made by Mayor Starrs, seconded by Deputy Mayor Cuntala and approved by all-in-favor to open to public comment.

Resident Rene Mathez- asked for an update regarding COAH. Mayor Starrs explained that at the last township meeting a check was cut for \$15,000.00 for a property on Clinton St. Attorney Dick Cushing stated that they are going through the final process regarding the litigation.

Resident Nancy O'Neill read her comments to the committee regarding the Draft Music Ordinance. Concerns that Mrs. O'Neill had were filing for a permit, fines associated with violations, parking, and enforcement of the ordinance.

Resident Becky Day asked what the time process was for the renewal of the 2019 Master Plan. Attorney Cushing explained that the Master Plan is done by the Planning Board. Mayor Starrs stated that she and Deputy Mayor Cuntala are both on the Planning Board and the Planning Board is going to start in the new year.

# **DEPARTMENT REPORTS**

#### Fire & Rescue-- Chief Dean Hill

It has come to Chief Hill's attention that Fire & Rescue does not have Mutual Aid agreements with Upper Mount Bethel and Portland fire departments. Attorney Cushing thought that this was taking care of already. Mr. Cushing will look into the matter and take care of the agreements.

Mayor Starrs asked Acting Clerk Shipps for an update on the Knox box waivers. Acting Clerk Shipps said that all the information has been sent out and we have received only one signed waiver from a business.

Mayor Starrs had asked Chief Hill for his input regarding complaints that the committee members have received regarding St. Luke's responding to emergency calls in Belvidere, which are happening more frequently and may hurt response time in Knowlton. Mr. Hill explained that there is a mutual aid agreement with Belvidere and St. Luke's may not be willing to station the squad in Knowlton if they respond to only Knowlton calls; St. Luke's needs the extra call volume to be profitable. Committeeman Van Horn and Shipps will approach Belvidere Township Committee about the problem.

# **Ted Rodman-Township Engineer**

Salt Shed—Once building permits are issued the salt shed will be started. Storm water Management update. Watershed Ambassador will visit the Elementary School on December 15th. Total points 9 with three more to go.

WHEREAS, the owner of the above property used the online payment system to pay past due and current taxes on the property in the amount of \$322.96 on Monday October 16<sup>th</sup>. Due to computer problems at their house they were not sure the payment had been completed. On Wednesday October 18<sup>th</sup>, their computer worked again and checking their bank account the payment had not been deducted from their account so they made the payment again. They did not realize the payment system is not automatic in posting and processing payments. Both payments have been received and an overpayment of \$322.96 now exists.

#### **Draft Music Ordinance**

Committee agreed to hear public comments regarding the Draft Music Ordinance since there were several residents and business owners present.

Concerns that the residents of Delaware bought up were enforcement, permit fees, the frequency of events, safety issues, the quality of life that is being affected by the noise and the number of people at the event.

Business owners of Hunter's Lodge were also present and said that they have been very careful about the music that they have outdoors.

Business owner of Brook Hollow Winery is concerned about the wedding events that he has at the winery and that if there is going to be a restriction on music events that this ordinance will put him out of business.

After listening to residents and business comments and much discussion between the township committee members, Committee members Van Horn, Farber and Shipps said they were not in favor of going forward with this. Mayor Starrs said this topic had been discussed for many months without finding a compromise and there will not be enough votes for this ordinance to be introduced, so it is dead.

# **Abandoned Building Registry**

Motion was made by Mayor Starrs, seconded by Deputy Mayor Cuntala and approved by an all-infavor to have Attorney Cushing compare the sample Abandoned Building Registry ordinance with other ordinance that the township has to make sure there is no conflicting parts.

Mayor Starrs read a statement from Pensions and Benefits showing the benefit for those two employees costs \$2,257 per month. Committee discussed the rising cost of health insurance and that Medicare is available to retirees.

#### **PUBLIC COMMENT**

Fire Chief Dean Hill asked the committee to consider having Knox box for the municipal building and for the DPW.

Resident Jeff Milesky stated that there was a JCP&L meeting and that he reached out to OEM Frank Makowski. He did not return Mr. Milesky's phone call yet. Mayor Starrs explained there was a leak of several hundred gallons of "oil transformer non-PCB" at the JCP&L substation on October 4, 2017. JCP&L has dismantled the substation and a licensed site remediation professional is handling the cleanup, which is supposed to be complete in 30 days. Soil testing shows contamination has not spread beyond the property. Mr. Milesky asked if someone from OEM could visit the site. Committeeman Van Horn, who is the Deputy OEM, told Mr. Milesky to call him personally if there are

any problems.
