Mayor Starrs led the public in the Pledge of Allegiance.

Stan Prater from JCP&L provided the committee with an update regarding the supplemental tree trimming granted for Meadow Ridge Road. Markings and identifying of trees have already begun. Tree trimming will start around the week of June 22nd. JCP&L will then install the trip saver after the tree trimming is completed. The total process will take approximately 5 weeks.

DEPARTMENT REPORTS

Township Engineer Ted Rodman-

There are no new updates from the problems statements that were sent out for Route 80/ Simpson Road exit ramp and for Bruglar Road no truck signs.

Paperwork has been submitted for the overlay of Linnabery Road a resolution will be introduced at the next township meeting.

Paperwork has been submitted for the 2021 grant for an overlay of Mt. Pleasant Road from Route 94 to the bridge on Hemlock Rd.

Mr. Rodman explained that the Sam Milron owner of the new Simpson Rd. travel center has requested for a minor adjustment to his original plans to have electric charging station installed which was granted by Mr. Rodman.

Mr. Rodman submitted the emergency permit for Hemlock Rd to NJDEP because it is along a C1 stream. Knowlton Township's DPW was working on Hemlock Road but has stopped until approval of the permit.

Discussion took place regarding trucks going on Decatur Street. Committeeman Van Horn discussed about having an island put it at the beginning of Decatur St. off the ramp from route 80. Committeeman Van Horn is following up and will reach out to the County Engineer.

Municipal Clerk Kristin Shipps

Clerk Shipps explained that she received a phone call from resident Alex Weber regarding Delaware Beach. There were people camped out overnight at the beach and they were in cars that were from out of state. Because the beach has signs stating "for residents only" the police were called but nothing was done about it. Attorney Parikh agreed to look in to the situation more and Clerk Shipps agreed to contact Mr. Weber to get more details on why the police did not issue a ticket.

Discussion took place on when the governor will announce opening government buildings and how the municipal building will handle social distancing. Clerk Shipps explained that there is already Plexiglass in the clerk's office as well as the court her only concern would be the construction and zoning department. She suggested getting a thick clear plastic sheet to hang in the window. If there is a need to sign documents with a resident, mask must be worn. Clerk Shipps agreed to get the plastic sheet.

2020-74- Resolution of the Township of Knowlton Authorizing Temporary Procedures to Assist Certain Establishments with Outdoor Dining Permits during COVID-19 Pandemic

WHEREAS, Governor Murphy has issued Executive Order No. 150 permitting, in part, the resumption of outdoor dining and beverage sales and consumption with restrictions imposed by the New Jersey Department of Health; and,

WHEREAS, according to Executive Order No. 150, effective at 6:00 a.m. on Monday, June 15, 2020, restaurants, cafeterias, dining establishments, and food courts, with or without a liquor license, bars, and all other holders of a liquor license with retail consumption privileges, collectively referred to as "food or beverage establishments," are permitted to offer in-person service at outdoor areas; and,

WHEREAS, on June 3, 2020, the State of New Jersey Department of Health has issued Executive Directive No.20-014, which further Ordered and Directed food and/or beverage establishments offering service at outdoor areas pursuant to Executive Order No. 150 to adhere to certain guidelines and protocols; and

WHEREAS, on June 3, 2020, the State of New Jersey, Department of Law and Public Safety/Division of Alcohol Beverage Control (NJABC) issued Special Ruling 2020-10, authorizing a process pursuant to which certain food and beverage establishments may obtain a temporary COVID 19 permit to expand licensed premises through their local municipalities and the NJABC; and

WHEREAS, the Township is desirous to assist restaurant businesses during the COVID-19 pandemic and emergency by establishing an expedited process for the possible temporary expansion of the space available for outdoor dining in compliance with Executive Order No. 150, State of New Jersey Department of Health has issued Executive Directive No.20-014 and Special Ruling 2020-10

NOW, THEREFORE, BE IT RESOLVED that, in light of the fact that Executive Order No. 150, and

Department of Health Executive Directive 20-014 and Special Ruling 2020-10, have specifically allowed outdoor dining to resume with the restrictions contained therein, the Township of Knowlton hereby temporarily waives any regular procedures for land use permits for outdoor dining expansion by permitting businesses to submit an expedited Outdoor Dining Permit application and plan (Expedited Application and Plan) for the balance of the year 2020, including the potential expansion of such dining onto sidewalks and parking lots, to the Township appropriate Code official for review; and,

BE IT FURTHER RESOLVED, the appropriate Code Official, in consultation with the Fire Code Official, Sub code Official, local Police Department and the Board of Health and any other official deemed necessary, shall review such Expedited Application and Plan on an expedited basis, pending necessary NJABC permit, if applicable and shall work with such business to reach accommodations to assist such businesses with obtaining an Outdoor Dining Permit from the Township, keeping in mind that the safety and health of the public shall be of the utmost importance; and,

BE IT FURTHER RESOLVED, that once the appropriate Code Official, in consultation with the other aforementioned Township officials, is satisfied that the business has demonstrated that their outdoor seating plan is safe for customers, staff and the general public, she/he shall issue such Outdoor dining permit; and,

BE IT FURTHER RESOLVED, that the fees associated with such Outdoor Dining Permit shall be waived for the year 2020 to assist such businesses during the COVID-19 pandemic and

BE IT FURTHER RESOLVED that all approvals granted pursuant to this Resolution shall expire on December 21, 2020.

Land Conservancy Proposal

Committeeman McNinch provided the committee with a proposal from the Land Conservancy to update Knowlton's open space plan, which is required by law every ten years. Discussion took place regarding where the funds will come from. Attorney Parikh will look at the wording from the Open Space Referendum and the Ordinance to see if the funds can be used from Open Space. A resolution will be introduced at the next meeting for Professional Service.

Delaware River Camp Ground

Committeeman Van Horn discussed an agreement that the committee had with Delaware River Camp Ground a while ago regarding the campgrounds using the Columbia Beach boat launch for patrons at the campground. Delaware River campground manager called into the meeting and commented that they giveresidents of Knowlton a discounted rate at their campground in exchange. After discussion with the manager of the campground committee agreed to continue with the past agreement and asked to formalize it in writing.

Mayor Starrs read an email from CFO Christine Rolef suggesting reducing the funds that are given to KAA and the Knowlton seniors by 50%- 75% since they are not meeting due to Covid. Committeewoman Cuntala agreed to contact KAA to see if they will get reimbursed for insurance. Committee agreed to not make any cuts to the senior funding.
