# TOWNSHIP OF KNOWLTON COUNTY OF WARREN, STATE OF NEW JERSEY TOWNSHIP COMMITTEE MEETING February 12, 2024

The meeting of the Knowlton Township Committee was held on this date at the Knowlton Municipal Building, 628 Route 94, Columbia, New Jersey and was called to order at 7:00 p.m. by Mayor Shipps. Mayor Shipps led the public in the Pledge of Allegiance.

Mayor Shipps read the following statements "This meeting of the Knowlton Township Committee is being held in compliance with the Open Public Meetings Act: P: 1975, Chapter 231, noting that notice of all regularly scheduled meetings has been published in the *New Jersey Herald* and/or Express Times as well as providing said schedule in the Municipal Clerk's office."

#### PUBLIC COMMENT- Limited To 20 Minutes With 3 Minutes Per Member Of The Public

Mr. Fred Bauer addressed Township Attorney Tara St. Angelo regarding the recent property auction held by Max Spann that took place in December. Mr. Bauer requested an update on the status of the closing documents for a property he acquired during the auction. Ms. St. Angelo advised Mr. Bauer that she is moving forward with the closing documents and she will have them sent to Max Spann as soon as possible.

## **PRESENTATION**

Commissioner Lori Ciesla

Commissioner Lori Ciesla updated the public regarding resident concerns with truck traffic on Decatur Street. The County has met with the State Police to discuss how they handle these transportation issues which include implementing a gross vehicle weight rating restriction which will allow law enforcement to address trucks by their rating without having to weigh them. Ms. Ciesla addressed the signage issue with the NJDOT commissioner which will be resolved in the near future. Ms. Ciesla answered questions from the public.

Ms. Ann Longyore on Decatur Street advised Ms. Ciesla there were 26 trucks on her road in 1 day. Ms. Ciesla advised Ms. Longyore if she notices the company of these trucks, to forward that information to Mayor Shipps so it can be addressed directly.

Ms. Colleen Hill on Decatur Street stated she has home surveillance that captures trucks speeding which is dangerous as children live and play on that road. Ms. Ciesla advised Ms. Hill she will address these concerns with the County.

Ms. Pam Rusweiler on Decatur Street advised Ms. Ciesla that their power and cable lines have been taken down twice in one month due to truck traffic. Ms. Rusweiler suggested making some side streets one way which could alleviate these issues. Ms. Ciesla advised Ms. Rusweiler she will address these concerns with the County.

Ms. Sharon Valentine on Decatur Street discussed her concerns with the increase of truck traffic due to the warehouse being built in the neighboring town. Mayor Shipps states there is going to be 88 trucks coming from the interchange a day to and from the warehouse.

Ms. Anna Van Wettering on Decatur Street advised Ms. Ciesla that there are large cracks in her home due to weight of the trucks on the road. Her house constantly shakes as trucks pass by. Ms. Ciesla advised this is why the weight limits needs to be enforced.

Mr. Paul Dulaff on Hainesburg River Rd addressed Ms. Ciesla regarding an ordinance related to Route 94 in Knowlton and truck restrictions. At some point in time, the ordinance has changed but he is having difficulty finding the year the ordinance was amended. Ms. Ciesla stated she would look into that date for him.

# The Nature Conservancy

Ms. Beth Styler Berry, the director of the freshwater program informed the public that the signs have been installed in Columbia regarding historic signs of the dam and the restoration along the Paulins kill.

Elliot Nagele with The Nature Conservancy presented proposed plans for the 9/11 memorial trail which goes through Knowlton Township. The Nature Conservancy recently acquired a 42 acre property in the Township which would provide a protected portion of the trail.

Mr. Rene Mathez suggested placing signage along the trail in memory of Bruce Reynolds, a Knowlton Township resident who lost his life during the 9/11 attacks. Mr. Nagele appreciated the suggestion and looks forward to working with the residents.

Committeeman Bates asked Mr. Nagele who will own the 42 acre lot once the Nature Conservancy completes the trial. Mr. Nagele states the plan would be to sell it to Green Acres.

#### **Historic Commission**

Mr. Bob McNinch and Mr. Tom Drake presented the new sign for the history of railroads in Knowlton Township which will be located by Knowlton Beach. A copy of the sign will be available at the municipal building for residents to see.

## **DEPARTMENT REPORT**

Township Engineer-Denis Keenan

Township Engineer Denis Keenan presented a proposal to the committee to move forward with the mandated MS4 Tier A storm water permitting through the NJDEP. Mr. Keenan suggested updating the stormwater management plan which includes the mapping every storm drain and catch basin located in the Township.

Mayor Shipps made a motion to recess the meeting. The meeting was to reconvene in 30 minutes.

Mayor Shipps made a motion to convene the meeting.

Township engineer Denis Engineer will work together with Township Attorney Tara St. Angelo on all required ordinances by the NJDEP. Stormwater training is required for all DPW employees. By 2026, all streets with inlets will need to be swept. Committeewoman Cuntala asked if equipment will be provided for the street sweeping. Mr. Keenan suggested the state may provide additional funds but that has not been determined as of yet.

2024-31 Refunding 2023 & 2022 Property Taxes On Various Properties Granted A Disabled Veteran Tax Exemption

WHEREAS, Jamarcus Cortez Burton, who is the owner of block 62, lot 6.12 located at 31 Centerville Road, was evaluated by the US Department of Veterans Affairs to be permanently and totally disabled because of injuries suffered during active duty service. The Knowlton Township Tax Assessor granted a Disabled Veterans Exemption effective 22 October 2022; and

WHEREAS, his mortgage company continued to collect escrow and pay taxes to Knowlton for 2 additional quarters in 2023, namely \$2,633.47 on Feb 10, 2023 and \$2,633.47 on May 10, 2023 through Tax Service provider Corelogic, those funds are due back to the payor, since the property was no longer taxable; and

**WHEREAS**, according to NJSA 54:4-3.30 et seq, as amended by Public Law 2019, Chapter 413 - when a veteran or a surviving spouse of a veteran or serviceperson is determined to have suffered a permanent disability being total, paraplegia, or blindness caused by their active duty service, that the applicant be granted a property tax exemption on their dwelling house and the lot where the house is erected, if they so occupy this property and it is considered their legal residence:
